## **Roof Observations:**

- 1. The Roofing Contractor is on site at the time of the observations.
- 2. Previous Days Applications: Building 19-29 Upper Level/Lower Level
  - a. The new roofing system has been applied including the ridge vents/caps Vented Ridgecrest and the hip caps the Alaskan SBS.
  - b. Two window bays have not received the new roofing system yet.
  - c. The Wall flashings to be applied.
- 3. Today's Applications: Building 5-15 35 SQ Upper Level
  - a. The 28 gauge pre painted drip edge along the eaves and rakes has been applied.
  - b. The Roofing Contractor has applied the self adhered eave protector along the eaves at 36" onto the roofs field the eave protector has been run parallel with the eaves.

c. The Roofing Contractor has applied the synthetic underlayment felt Titanium UDL over the roofs field. The underlayment felt has been run parallel with the eaves.

- d. The BP starter strips along the eaves and the rakes have been applied.
- e. The Legacy SBS Malarkey shingles are expected to be installed by the days end.
- f. New neoprene gaskets and new exhaust vents are expected to be installed by the days end.
- 4. No major issues have occurred during my time of the observations.
- 5. Roofing materials have been placed at the designated parking area on the west.
